Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a writ of Certiorarified Mandamus calling for the records relating to the impugned order of the 2nd respondent in Roc.No.6487/2016/OP1 dated 9.5.2017 quash the same and consequently direct the respondents 1 & 2 herein to frame consolidated service rules for the posts sanctioned by 1st respondent in G.O.Ms.No.2 MA & WS Dept., dated 4.1.1999 and appoint the petitioner as Junior Engineer / Assistant Engineer with re-designation from the present post of Draughting Officer Grade-II with all consequential monetary and attendant benefits including promotion etc.
