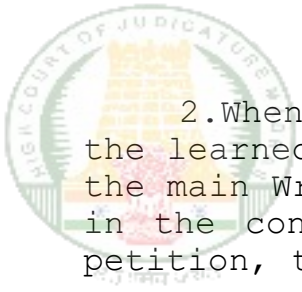
Prayer in WP(MD) . 5563/ 2021 :
