Prayer : Criminal Original Petition filed under Section 482 of the Code of Criminal Procedure, to direct the learned District Sessions Judge, Karur, (PCR Court) to consider the bail application to be filed by the petitioner on the same day in Crime No.231 of 2021 on the file of the Inspector of Police, Chinthamanipatty Police Station, pending investigation with such terms and conditions imposed by this Court.

ORDER

The petitioner is the fifth accused in Crime No.231 of 2021 of Chinthamanipatty Police Station, Karur District and the offences alleged against the accused are under Sections 147, 341, 294(b) and 323 of IPC and Sections 3(1)(r), 3(1)(s) and 3(2)(Va) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Amendment Act, 2016.

2.The present petition filed by the petitioner is to direct the learned District Sessions Court (PCR Court), Karur, to accept the surrender of the petitioner and also to consider the bail application on the same day.



3.Mr.R.M.Anbunithi, learned Government Additional Public Prosecutor accepts notice for the respondents 1 and 2. The third respondent is the de-facto complainant.

4.Since the prayer itself is to accept the surrender of the petitioner and consider the bail application, this Court is inclined to pass the following orders :-

- 1) The petitioner should appear before the learned District Sessions Court (PCR Court), Karur,, within a period of 15 days from the date of receipt of a copy of this order / uploading of the order.
- 2) On such surrender, concerned Sessions Judge, may consider the bail application filed by the petitioner on merits on the same day of surrender, after giving notice to the concerned Public Prosecutor and by complying Section 15(5) of the Act.

5.With the above observation, this Criminal Original Petition is disposed of.
