Prayer: Writ petition filed under Article 226 of the Constitution of India, for the issuance of Writ of Certiorarified Mandamus calling for the records leading to the issuance of the original impugned high Tension Bills (Provisional) issued by the Second Respondent for the month of March 2020 dated 03/04/2020, April 2020 dated 03/05/2020, May 2020 dated 01/06/2020, June 2020 dated 03/07/2020, July 2020 dated 05/08/2020 and August 2020 dated 03/09/2020 pertaining to Service No. 059094630172 in violation Regulation 6 (b) of the Tamil Nadu Electricity Supply Code 2004 and quash the same and direct the Respondents to rework the HT bill with service number 059094630172 and the excess amount shall be adjusted towards the future bills and the minimum charges alone shall be collected by the second respondent for the period from March 2020 to August 2020 and not to levy penalty for the period of Lock Down.
