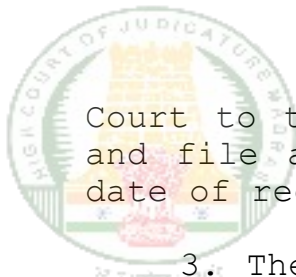
ORDER:-
