PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondents for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.3834 of 2020, dated 26.02.2020.

Prayer in WP(MD). 3834/ 2020 :

Writ Petition is filed under Article 226 of the Constitution of India, to issue a writ of mandamus praying this Court directing the respondents to pay 18 percent interest for the belated payment of terminal benefits of PF Gratuity and unavailed leave salary and commutation payable to the petitioner from the date of his retirement i.e., 31.5.2018 to till the date of actual payment made to him ie., 21.9.2019 and all other attendant benefits to him within the stipulated period.
