Prayer in CRL MP(MD) . No.4508 of 2021 :-

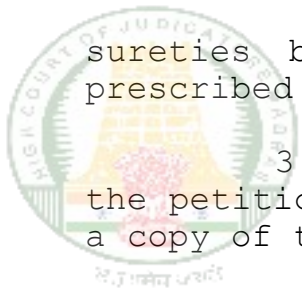
