The case of the petitioner is that he is the defacto complainant in Crime No.24 of 2019, which was registered for the offences punishable under Sections 279, 337 & 304(A) IPC and even though Charge Sheet was filed and the same was taken on file in CC No.20 of 2020 by the learned Judicial Magistrate, Melur, Madurai and it is pending for more than a year without serving summons to the accused persons.
