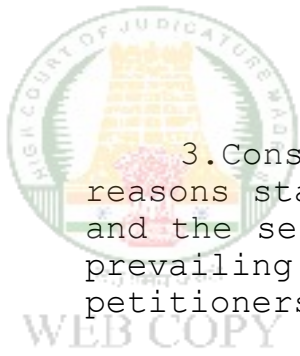
PRAYER IN CRL MP(MD)No.3209 of 2021 in CRL OP(MD)No.2924 of 2021:
