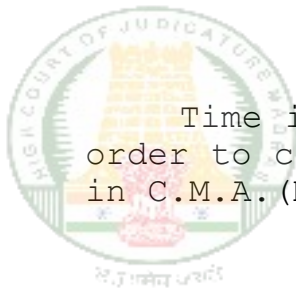
PRAYER IN C.M.P. (MD) .No.2959 of 2021
