Considering the facts and circumstances of the case and also considering the submission made by the learned counsel for the petitioner and also the prevailing COVID-19 pandemic situation this petition is allowed and the time for producing the sureties is extended by four weeks from the date of receipt of a copy of this order as a last chance.
