Prayer in CRL MP(MD). No.5834 of 2021 :-

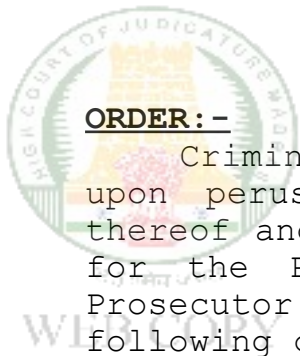

No.2170 of 2021 in Crl.OP(MD) No.2066 of 2021 which was allowed on 15.03.2021.

Prayer in CRL MP(MD). No.2170 of 2021 :-

Criminal Miscellaneous Petition is filed under section 482 of Criminal Procedure Code, praying this Hon'ble Court to extend the time granted for file a bail application before the concerned Court for a further period of 15 days in Crl OP(MD). No.2066 of 2021 which was allowed on 11.02.2021.

Prayer in CRL OP(MD). No.2066 of 2021 :-

This petition has been filed to extend the time granted in the order dated 15.03.2021 made in Crl.M.P(MD)No.2170 of 2021 in Crl.O.P (MD) No.2066 of 2021, on the file of this Court.

2.By order dated 02.07.2021 liberty has been granted to the petitioner to file a fresh petition seeking extension of time and on that ground this petition came to be filed.

3.Today, the learned counsel for the petitioner would submit that due to lockdown, the petitioner could not execute the sureties and surrender before the concerned Court within the stipulated time prescribed by this Court and hence seeks extension of time.

4.Considering the request made by the learned counsel for the petitioner, 15 days time is extended from the date of receipt of a copy of this order.

5.Accordingly, this Criminal Miscellaneous Petition is ordered.
