In the result, the Contempt Petition is closed.

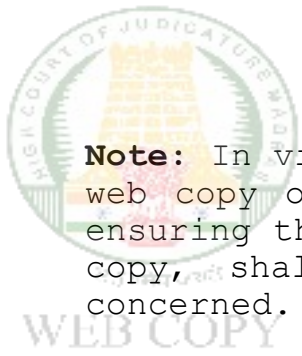
