3. In the considered view of this Court, this Writ Petition is premature. An application has been given before the respondents only on 11.06.2021 and a representation was sent on 15.06.2021 and within a span of hardly 20 days, the present Writ Petition has been filed before this Court. This Court is not a Post Office to



mechanically issue directions where the petitioners had not even give some time for authorities to act upon the application / representation. Hence, this Writ Petition is dismissed as prematured. No costs.
