Prayer: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the entire records of the second respondent insofar as the High Tension Bill (Provisional) for the months of April 2020 dated 03.05.2020, May 2020 dated 03.06.2020, June 2020 dated 03.07.2020, July 2020 dated 05.08.2020 and May 2021 dated 05.06.2021, pertaining to High Tension Consumer Connection vide Service No.059094630166 and quash the same and consequently direct the respondents to rework the HT Bill with Service No.059094630166 the excess amount shall be adjusted towards the future bills by levying the minimum charges alone by the second respondent for the months of April 2020, May 2020, June 2020, July 2020 and May 2021 and not levy any penalty for the lockdown period under which the petitioner's Textiles Showroom building, situated at Nos.47 and 48, East Veli Street, Madurai-625 001.
