PRAYER IN S.A(MD)SR.No.7727 of 2021:

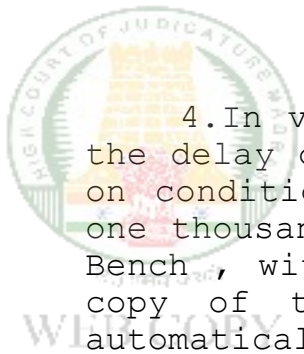
