Prayer in Crl M.P (MD) No.8515 of 2021:-

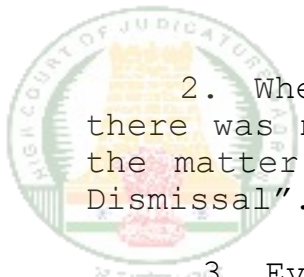
