Hence, he prays to grant further time to execute the sureties.

Considering the facts and circumstances of the case and also considering the submission made by the learned counsel for the petitioner and also the prevailing COVID-19 pandemic situation this petition is allowed and the time for producing the sureties is extended by two weeks from the date of receipt of a copy of this
