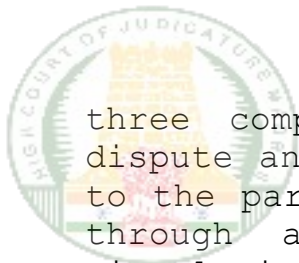

2.When the matter taken up for hearing on 09.07.2021, the Learned Additional Public Prosecutor has submitted that there are



three complaints filed by the petitioner regarding the land dispute and all the complaints came to be closed with a direction to the parties to approach the Civil Court for appropriate remedy through appropriate proceedings. The matter was listed for circulating a copy of the Closure Report to the learned counsel for the petitioner. Now, the copy of the Closure Report has also been circulated to the learned counsel for the petitioner. Since the complaints, made by the petitioner came to be closed, the petitioner is directed to work out her remedy, before the appropriate Court through appropriate proceedings.
