Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus or any other appropriate writ or order or direction in the nature of writ, directing the 5th Respondent to comply with the order passed by the 2nd Respondent vide his Proceedings in Na.Ka.No. 1122/2020/Thu.Ma.A-2, dated 27.04.2021 by receiving 3 percent of the guidelines value fixed by the Registration Authority for the School land by issuing bank Challan and covering letter mentioning the amount of 3 percent of the guidelines value fixed by the Registration Authority for the



school land and Rs.1000/- as processing fee and issue the Plan Approval within the stipulated time as fixed by this Hon'ble court and pass such further or other orders as this Honourable Court may deem fit.
