2.In view of the memo, this Criminal Miscellaneous Petition is dismissed as withdrawn.

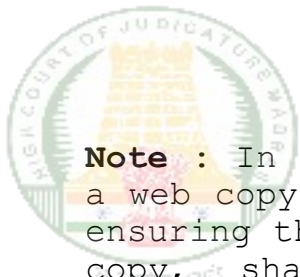
