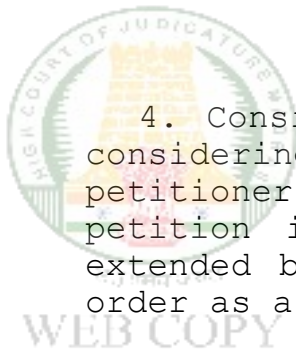

Hence, he prays to grant further time to execute the sureties.
