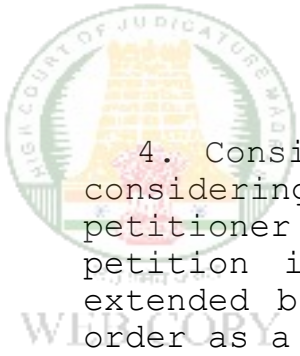

The learned counsel appearing for the petitioner would submit that the petitioner is unable to arrange sureties and could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.
