Prayer in CRL MP (MD) No. 4790 of 2021:-

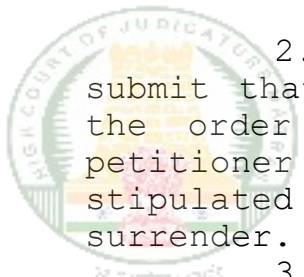
