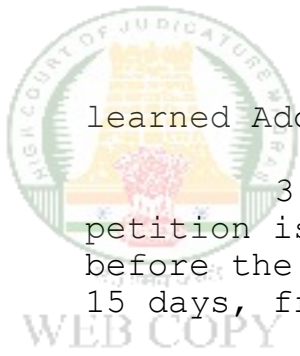
PRAYER IN CRIMINAL ORIGINAL PETITION (MD) NO. 6465/2021:
