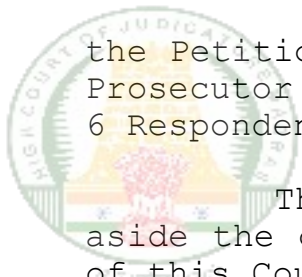
Prayer in CRL MP (MD) . No.5844 of 2021:-
