Prayer in WP(MD). 11046/ 2019 :

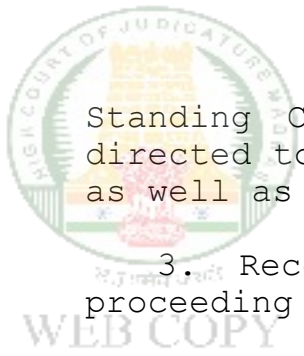
