Petition praying that in the circumstances stated therein and in the affidavit filed therewith, the High Court will be pleased to issue a Writ of Habeas Corpus calling for the records from the second respondent in P.D.O.No.25/2021 dated 10.05.2021 by setting aside the said order of detention passed by the second respondent and setting the detainee, Ramesh Babu @ KSR Ramesh, aged 38, S/o.Sankaran, at liberty now detained in the Central Prison, Trichy.

2.Heard Mr.V.Kathirvelu, learned Senior Counsel appearing for the Petitioner and Mrs.S.Ravi, learned Standing Counsel for the State appearing for the respondents and perused the materials placed before this Court.

3.When the matter is taken up for hearing today, the learned Senior Counsel appearing for the Petitioner seeks permission of this Court to withdraw this Petition.

4.In view of the above-said submission, this Petition is dismissed as withdrawn.

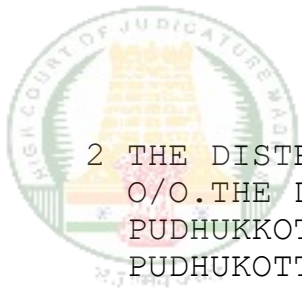
