3. The writ petition stands closed accordingly. No costs.

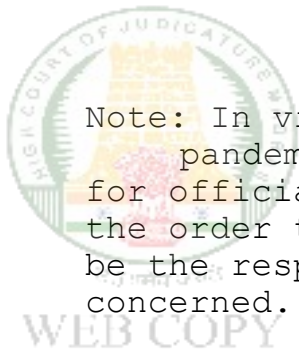
