PRAYER: Writ Petition filed under Article 226 of the Constitution of India seeking a Writ of Mandamus directing the respondents to conduct the survey and demarcate the assignment house site in S.No.54/4, 5, 76/11, 77/11 1B and 1C to an extent of 2.23.0 Hectares (Punja) and S.No.54/1, 2, 55/5, 6B, 8B, 9B, 76/1, 76/2 to an extent of 2.10.5 Hectares (Punja) allotted for the welfare of scheduled community people in Venthoni Group, Paramakkudi Taluk, Ramanathapuram District as per the 2nd respondent's proceedings in Na.Ka.A/1280/10 dated 27.06.2016 and Na.Ka.A/1243/2009 dated 27.06.2016 by considering the petitioner's representation dated 27.05.2019, within stipulated time that may be fixed by this Hon'ble Court.

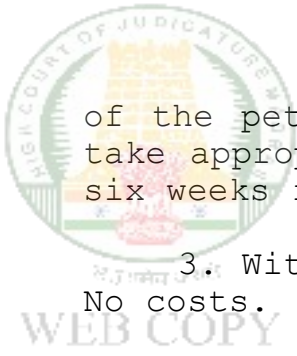
