3.When the matter is taken up for hearing, the learned Additional Public Prosecutor would submit that no complaint has been received either from the petitioner or from the third respondent.

4. On perusal of records, it is seen that the petitioner enclosed a copy of the representation even without signature. No postal receipt is also submitted.

Recording the submission of the learned Additional Public Prosecutor that no complaint has been received and also considering the fact that there is no proper representation given by the petitioner, this Criminal Original Petition is dismissed. The petitioner is at liberty to submit a fresh representation with signature and also file a fresh application, if any necessary arises.
