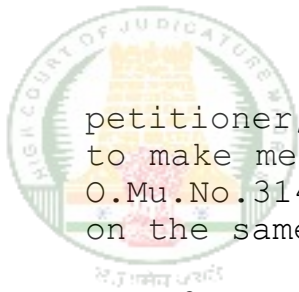

2.
