Prayer: Criminal Original Petition is filed under Section 482 Cr.P.C., to direct the respondents 1 to 3 not to interfere in the civil dispute between the petitioner and the fourth respondent with regard to lands in Survey Nos.221/12A and 221/12B measuring to an extent of 0.4.00 Ares and 0.2.00 Ares and total extent is 0.06.0 Ares (15 Cents) situated in his native village I.e, Sirunallur Village, Akkaloor Group, Nakarikathan Post, Thiruvadanai Taluk, Ramanathapuram District and consequently direct the third respondent not to harass the petitioner.
