Order :This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of MR.D.MALAICHAMY, Advocate for the Petitioner and of MR.RMS.SETHURAMAN, Counsel for State Government (Crl Side) on behalf of the Respondent, this Court made the following order:

2. This Court by order, dated 30.03.2021 in Crl.R.C(MD)No.273 of 2021 directed the petitioner to deposit a sum of R.5,00,000/- (Rupees Five Lakhs only) to the credit of Cr.No.2 of 2020 within a



period of three weeks from the date of receipt of copy of that order. Failing which, the bail granted to the petitioner by the trial Court stands automatically cancelled. But the petitioner has not complied with the condition and he seeks extension of time to comply with the condition.
