Prayer in CRL MP(MD). No.5087 of 2021 :-

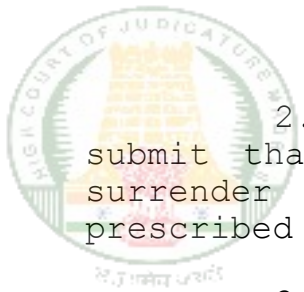
