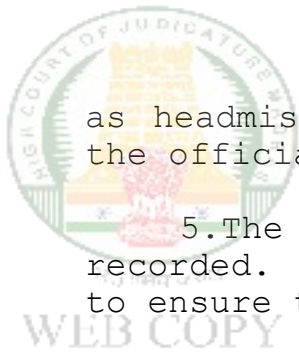
Heard the learned counsel on either side.

2.The petitioner filed W.P.(MD)No.16966 of 2015. It was allowed on 18.01.2018. Alleging that the said order has not been complied with, the present contempt petition came to be filed.

3.The petitioner's counsel submitted that the petitioner is not being allowed to discharge her duties as headmistress of the said school. I therefore issued statutory notice.

4.The contemnor appeared before me and has filed an affidavit stating that they are allowing the petitioner to discharge her duty
