Prayer in CRL A(MD). 217/ 2020 :

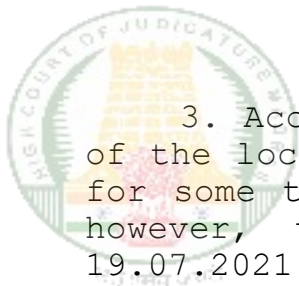
(Sole Accused) Offence U/s.302 IPC- Life Imprisonment and to pay a fine of Rs.1000/- i/d., 3 months S.I.

This petition has been filed seeking modification of the condition imposed in Crl.M.P.(MD).No.708 of 2021 in Crl.A.(MD).No.217 of 2020, dated 18.02.2021.

2. It is represented by the learned counsel appearing for the petitioner Mr.T.Antony Arul Raj and Mr.S.Ravi, learned Standing counsel appearing for the respondent that the petitioner has complied with the condition from 05.03.2021 to 11.05.2021.
