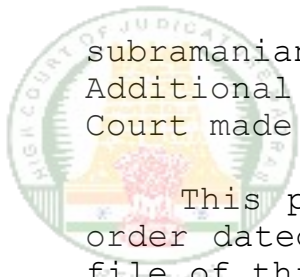

5. Further, considering the request made by the learned counsel for the petitioner, 15 days time is also extended from the date of receipt of a copy of this order.
