Prayer in WP(MD). 1765/ 2020 :

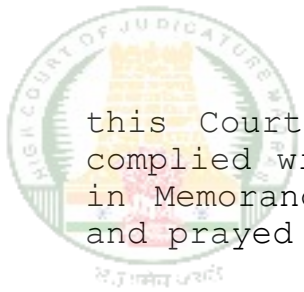
