This criminal original petition has been filed for quashing the First Information Report in Crime No.675 of 2020 registered on the file of the Inspector of Police, Kanyakumari police station, for the offence under Sections 354A, 384 and 506(1) of I.P.C., and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002 and Section 67 of Information Technology (Amendment) Act 2008.
