Prayer in CRL OP(MD) . 5705/ 2021 :

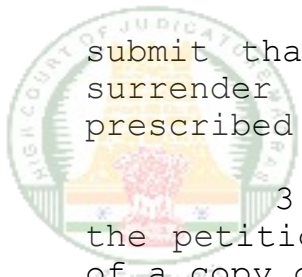
