This petition has been filed to modify the condition imposed on the petitioners in Crl.O.P.(MD)No.9472 of 2021, dated 16.07.2021.

2. The learned counsel appearing for the petitioners submits that this Court, while granting anticipatory bail on 16.07.2021, imposed a condition by directing the petitioner to appear before the respondent Police (Kovilpatti Police Station, Thoothukudi) daily at 10.30 a.m. until further orders. The learned counsel further submits that since there is a threat to the life of the petitioners, they seek modification of the said condition.

4. Considering the fact that there is a threat to the life of the petitioners, the condition imposed on the petitioners are modified to the effect that the petitioners shall report before the Tirupur North Police Station, Tirupur District, daily at 10.30 a.m., until further orders.
