In view of the subsequent developments, this contempt petition is closed. The rights of the petitioner are left open.

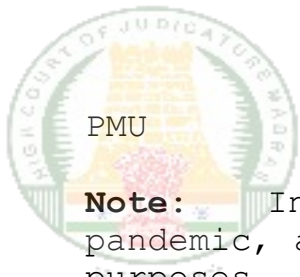
