PRAYER :-

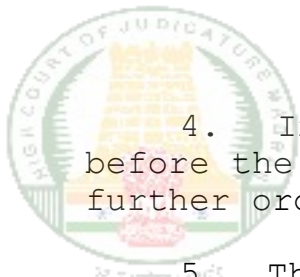
For Anticipatory Bail in Crime No. Not known of 2021 on the
