Prayer in WP(MD) . 3837/ 2020 :

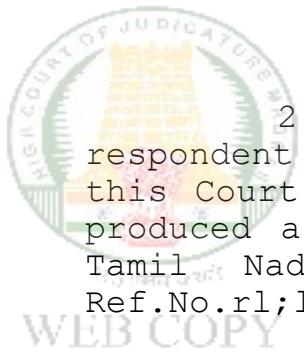
