Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a writ of Mandamus to directing the respondents to pay the service surrender leave salary amount of Rs.1,33,300 payable to the petitioner for the period of 2008 to 2018 together with 18 percentage interest from the date of his retirement i.e. 30.4.2018 to till the date of payment and all other attendant benefits to the Petitioners within the stipulated period
