Even thereafter, the petitioner has not complied with the condition and filed this second extension petition. This Court is not satisfied with the reasons assigned in the petition. Therefore, this petition is dismissed, however, liberty is granted to the petitioner to file a fresh application for anticipatory bail, if so advised.
