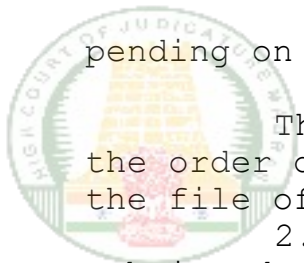
Prayer in CRL MP(MD) . No.5453 of 2021:
