PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory Bail in Crime No.59 of 2021 on the file of the Respondent Police

ORDER : The Court made the following order :-

The petitioner/A1 apprehending arrest at the hands of the respondent police for the alleged offence punishable under Sections 294(b), 452, 323, 324 and 506(ii) I.P.C. in Crime No.59 of 2021 on the file of the respondent police, seeks anticipatory bail.

2.This is the second anticipatory bail application. The first anticipatory bail application was dismissed by this Court on 23.06.2021 in Crl.O.P(MD).No.8191 of 2021.

3.It is reported by the learned Government Advocate (Crl.side) appearing for the respondent police that the petitioner is a history sheeted rowdy in History Sheet No.714 of 2008.

4.Though this court by an earlier order dated 23.06.2021 has dismissed the anticipatory bail application as against this

petitioner who is a history sheeted rowdy, the respondent police has not taken any effective steps to secure the petitioner and therefore, the second application has been filed by the petitioner.

5. Considering the facts and circumstances of the case, the fact that this petitioner is a history sheeted rowdy and there is no change in circumstance in the case to consider the present application, this Court is not inclined to grant anticipatory bail to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
