2021, seeks anticipatory bail.

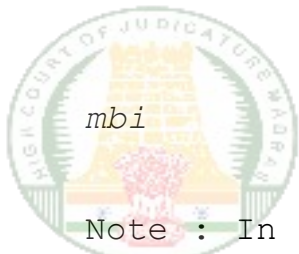
2. This is a second anticipatory bail petition. The earlier
